



2022-23 Virtual Learning and eLearning Plan

Dear HCCSC Families,

House Bill 1093 Education Matters, became law, went into effect July 1, 2022, and the Indiana Department of Education has released requirements for Virtual Learning and eLearning for the 2022-23 school year. Based on this new law, HCCSC has developed the following plan as a result of these requirements:

1. Snow make-up day – 3 days have been designated on the calendar as Snow make-up days, which are:
 - December 21, 2022
 - December 22, 2022
 - May 25, 2023

If school is canceled due to inclement weather, students will not attend school on the canceled day, will not have eLearning or Virtual Learning; and will then attend on these make-up days. These days will be the first to be used when there is a cancellation. If there are no closings due to inclement weather, students will not be in school on these designated dates.

2. eLearning day – 3 days to be used after the snow days for cancellations due to inclement weather. Students will not come to school on the canceled days, lessons will be posted by 10:00 am and students will log on to complete their work from 10:00 am – 3:00 pm for both elementary (grades K-5) and secondary (grades 6-12). These days are asynchronous learning. Office hours for teachers will be 10:00 am – 4:00 pm.
3. Flex day for PD – 3 days designated on the calendar:
 - September 30, 2022
 - November 14, 2022
 - February 20, 2023

PLEASE NOTE: This is a change from previous years Flex days where students did not attend the entire day in person. We feel it is important for our students to have the opportunity for in-person learning. These days will be a 2-hour delay schedule for students, and they will attend school in person for the remainder of the day. Teachers will participate in professional development for the first two hours of the day.

4. Virtual days – H. B. 1093 requires Virtual days be synchronous learning for 3 hours per day for secondary (grades 6-12) and 2.5 hours for elementary (grades K-5), in which teachers will be “live” online with students. These days will begin after the 3 Snow make-up and 3 eLearning days, due to inclement weather, have been exhausted. Following will be the schedule for these days:

Teachers Available for Support	1:30 pm – 4:00 pm	2:00 pm – 4:00 pm

We will send reminders via SchoolMessenger ahead of time as we approach these scheduled days. This message is just to give you an overall view for this school year.
